Donation Explanations

*Donation Option 1: Make a one-time donation of \$1000 or whatever dollar amount you are comfortable contributing to Kappa Delta House Corporation. Please complete the pledge agreement and send both it and the check (made payable to Kappa Delta House Corporation) to the Laurus Group address listed on the form by April 1, 2011.

**Donation Option 2: Make a \$1000 donation payable in monthly \$200 installments over a five month period. Please complete the pledge agreement and send both it and your first payment (check made payable to Kappa Delta House Corporation) to the Laurus Group address listed on the form. We ask that if you use online banking that you set up an automatic check draft for the \$200/month for 5 months starting in January 2012.

***Donation Option 3: Pledge at the tax deductibility level of \$5000 payable over the next five years. Please complete the pledge agreement and send both it and the first \$1000 pledge payment (check made payable to Kappa Delta Foundation) to the Laurus Group address listed on the form. Subsequent payments will be billed to you on a yearly basis. By submitting your agreement and first payment by the end of 2011, your first tax deductible donation can be taken on your 2011 taxes. Alternatively, if you feel so inclined you could make a one-time \$5000 donation toward the campaign, making the entire amount tax deductible in 2011. This option will not only allow us to complete the Parking Lot project in 2012, it will also enable House Corporation to build a reserve to support a 5-10-15 year plan to keep the NEW HOME just that.

****Donation Option 4: Make a one-time \$3000 donation and place your name on a parking spot. We encourage you to consider making this one-time donation on your own or teaming with another sister or your pledge class. Please complete the pledge agreement and send both it and your payment totaling \$3000 (check(s) made payable to Kappa Delta House Corporation) to the Laurus Group address listed on the form.
